<u>Tour Confirmation</u>: Tour Participation can only be confirmed after receipt of the initial payment and this Discovery Tours Registration Card, providing there is space available. <u>Receipt of the Registration Card implies that the participant and guardian have read and understand all conditions listed on the Registration Information sheet and any other conditions set by the school or group leaders. It is the participant and guardian's responsibility to know and abide by these conditions. *All registration fees to Discovery Tours & Travel are non-refundable*.</u>

<u>Payment Conditions</u>: Payments must be kept up to date. If a participant falls behind the payment schedule, Discovery reserves the right to place that place participant at the end of the waitlist. Discovery or the group leaders may choose to cancel anyone who is not fully paid <u>within 90 days of departure or last payment due date</u>. All cancellation, late fees and penalties will apply. In some cases, customized payment plans may be arranged. <u>Please see back of this registration for other rules on payments. The registration fee reserves your space for the tour and the deposit confirms you will be attending <u>Returned Check Fee</u>: There will be a \$35.00 fee for checks returned unpaid. <u>Fundraising Money</u>: In the event of your cancellation from the tour, fundraising money will be refunded directly back to the tour account and may not be returned to the participant.</u>

<u>Behavioral Release</u>: Discovery Tours has the right to decline to accept or retain any person as a member of a tour at any time for any reason before or during the actual tour. Should the behavior of a participant endanger their safety or the safety of the group, they will be eliminated from participation and returned home at their (or their parent's) expense. If you become ineligible to go on the tour for any reason including before the tour begins "Discovery's" cancellation policy will be followed.

<u>Tour Deviations</u>: Under certain conditions, participants may be able to fly separately from the group, join the tour late, leave the tour early, or extend their stay. Any person desiring to deviate from the tour itinerary must file a Tour Deviation Request form with Discovery Tours and receive permission from the group leader. For each service required a <u>\$35 fee</u> from Discovery will be charged plus whatever the vendor may charge to complete.

<u>Delete:</u> Due to group pricing, individuals deleting portions of the itinerary or want to eliminate something from the tour will not necessarily be entitled to a refund or a price reduction on this tour.

<u>Itinerary</u>: The itinerary for this tour is subject to revisions, should circumstances make such changes necessary. A final itinerary with times, hotel addresses, and airline flights will be provided at the final per-trip meeting approximately one week prior to the trip or notice with information may be given by mail to the participant. <u>Price Increase</u>: The tour price is based on a minimum number of <u>50 paid participants</u>, or should the itinerary be changed, the tour price is subject to increase. Anyone who joins the tour after the Deposit date or first payment date, may be subject to paying a higher price.
